### PROFESSIONAL BIOGRAPHY

Sarah Dodd is a savvy media relations expert and award winning former journalist. Dodd spent more than a decade working as a television news journalist, and in 2007 she founded Dodd Communications, specializing in Media Strategy, Crisis Communications, Public Affairs and Community Relations. As a journalist, Ms. Dodd covered local, state and national politics. She worked as a television anchor/reporter in Dallas, Texas for seven years and during that time her investigative work led to one of the largest federal corruption investigations in the history of Dallas politics. While working for the CBS owned television station in Dallas, Dodd traveled to Kuwait, Iraq, South Korea, China and Guantanamo Bay. She was proud to be an embedded reporter, spending the first month of the war in Iraq.

During her decade long career as a television news reporter and anchor, Ms. Dodd earned the coveted Edward R. Murrow Award for Excellence in Journalism, multiple EMMY nominations, and the Iron Horse Award from the U.S. Army for Fair and Balanced news coverage. Dodd has also been a regular guest lecturer at Southern Methodist University's School of Journalism.

### PROFESSIONAL INTEREST FORM:

### PROFESSIONAL INTEREST FORM:

I would like to learn from community leaders and local officials what policies have been developed to address the real estate downturn, and how they have been tailored to particular types of real estate markets. This information will be instructive in my research and policy development work in the urban planning domain within California. A city planner or affordable housing organization could provide key perspectives.

*Personal Objective 2:* California has some of the strictest environmental laws in the nation, including the California Environmental Quality Act and the Sustainable Communities and Climate Protection Act. I have learned that one of the most difficult challenges to their effectiveness is the ability to enforce them. I would like to explore how Europe is addressing climate change and environmental issues, whether their laws and/or policies are developed at the local, national, or regional level, what they look like, how their success is measured, and the design of their enforcement mechanisms.

**Personal Objective 3:** Given the interconnectedness of European countries and their cities and towns to one another, through their economic and political systems and their spatial proximity, I would like to understand whether, and if so, to what degree, these countries rely upon regional government policies, specifically as to landuse planning and transportation. Although regional bodies are involved in land-use and transportation planning in California, enforcement authority resides for the most part at the city, state, and federal levels.
