Welcome to the 4th Mid-Term Conference of the Political Sociology Research Network 32 of the European Sociological Association in Brussels! With 22 panels, more than 100 researchers across Europe are participating in panels, plenaries and roundtables, making this an important moment in the life of our Research Network.

The ESA Political Sociology research network – founded in 2008 by Virginie Guiraudon, Carlo Ruzza and Hans-Joerg Trezn – is a site for debate on the ongoing transformation of political order and authority in Europe and beyond. We organize conferences and workshops both in the context of the activities of the European Sociological Association (ESA) and independently. In the context of the ESA we are the Research Network 32 and we organize panels at the biannual general conference of ESA (the last general conference took place in Prague, August 2015, the upcoming general conference will take place Athens from 22 to 25 August 2017) and interim conferences (the first one took place in Lille in November 2010, the second in Milan in November 2012, and the third one in Copenhagen in November 2014). We seek to support the research and publishing activities of our members. The Palgrave Studies in European Political Sociology, edited by Carlo Ruzza and Hans-Jörg Trezn, addresses contemporary themes of Political Sociology. Our Research Network is also associated with Participation and Conflict. We aim at providing a space for academic discussion and information on political sociology in Europe. We endeavour to link our association to other political sociology associations.

The 4th Mid-Term Conference will open with a plenary panel on Friday morning: Europe's handling of the refugee issue – getting out of the 'crisis'-modus? The evening plenary panel on Friday entitled Death of Multiculturalism? On Islam Integration in Europe will feature as keynote speaker Cristian Joppke. This opens the floor to a discussion with François Forêt and Iman Lechkar. The evening plenary session will be followed by a cocktail reception open to all participants. A presentation of the book series 'Palgrave studies in European Political Sociology' by its editors Carlo Ruzza and Hans-Joerg Trezn will take place on Friday during the lunch time session. The RN32 will meet on Saturday during the lunch time session. Every participant is welcome to join us!

(Dis)locating Europe: Conflicts, challenges and changes

Transformed migration flows, conflict, resistance and terror, the redefinition of freedoms in EU member states, and withdrawal from common commitments to welfare are dislocating the state-society bargains that underpinned the 'European societal model'. The ESA Political Sociology research network (RN32) is a site for debate on the ongoing transformation of political order and authority in Europe. With an aim to stimulate the study of the European polity with insights from sociology on the relations between the polity, people and policy, the network organizes concentrated mid-term conferences to highlight new research themes and stimulate in-depth discussions. Many issues deserve investigation from a political sociological perspective today. Challenging the place of Europe in our understanding are de-centrifugal tendencies such as Brexit and regional independence impulses (Catalonia, Flanders, Scotland, etc.), the actions of a variety of citizens' movements and new political organizations opposing social and political '(Euro-) sclerosis', and the transformation of the decision-making elite. The increased tolerance for rising socio-economic inequality and new conceptions of European identities and social borders further dislocates the understanding of European societies.

The 4th ESA RN-32 mid-term conference brings together researchers working within a European political sociological perspective to illuminate four sets of topics within the theme of conflicts, challenges and changes to European transnationalizing or re-nationalizing societies. The conference is organized in four inter-related sets of thematic sessions:

- 1. Resistances and backlashes:** Across Europe, collectivities mobilize, digging in/opting out. This theme welcomes research dealing with resistances from the right and the left, populism and social backlash, new parties and power balances, nationalism, mobilizations, and anti-politics.
- 2. Migration and mobilities:** Resilience and change of migration, mobility and integration policies, in-/exclusions, border politics, disadvantage, cosmopolitanism, participation and perceptions of 'race', nation and culture; as well as securitization and fear are all topics relevant to this theme.
- 3. Civil Society and democracy:** Where and who decides? This theme tackles changes in European decision-making, governance and relations to society. The role of changing elites (experts, think-tanks), NGO's and (re)activated grassroots, issues of inequalities in participation, and changing roles for social movements in Europe are topical here.
- 4. Diversity, equality and identity:** Submissions for this theme may focus on issues relating to citizenship and multiple identities, the intersections of class, gender, sexuality, age, religion, race, or disability, religion and secularism in Europe, value debates, public opinion, the role of media in framing and changing perceptions of belonging. Such issues are (re)defining and (re/dis)locating the nature of European societies and identities.

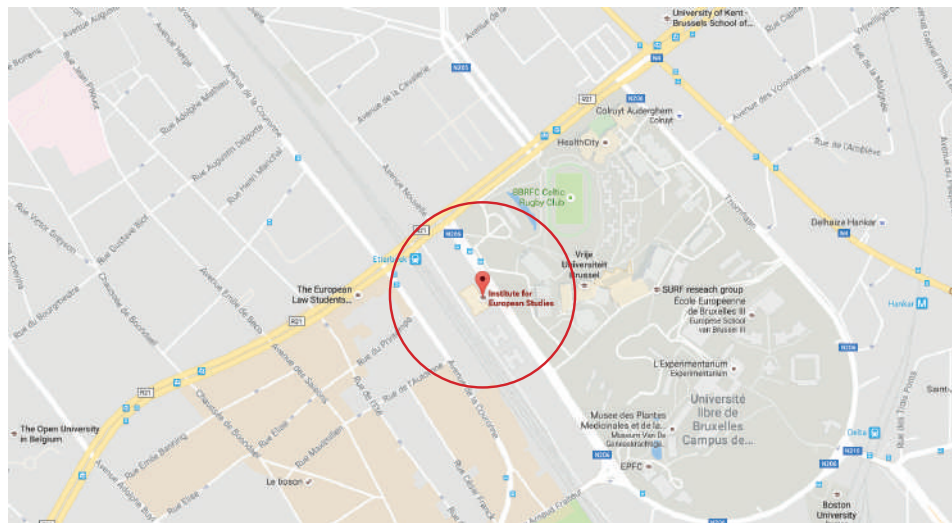

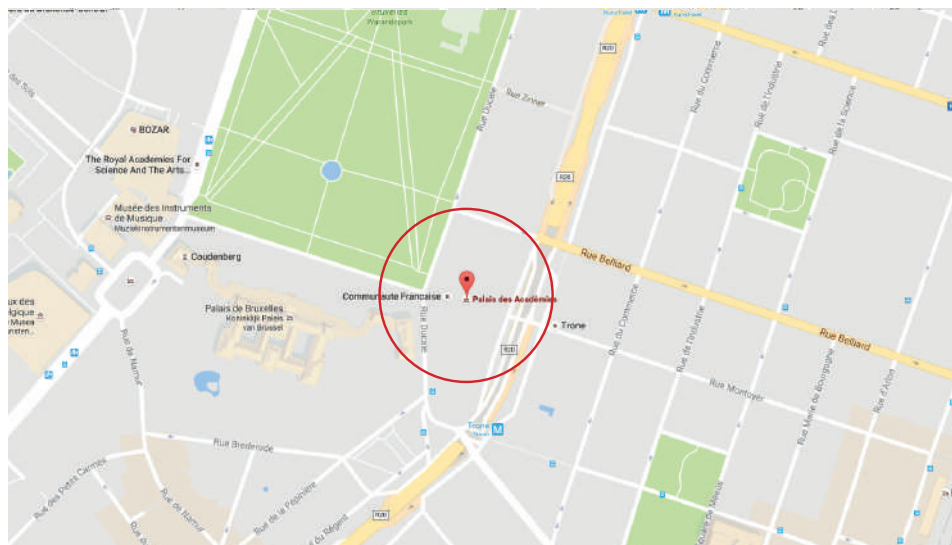

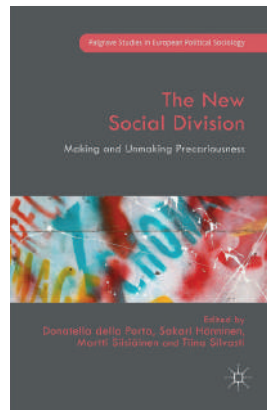
